PURPOSE OF THE STATEMENT

This statement is published by Quantiphi Limited (“**Quantiphi**”) in accordance with the requirements of Section 54 of the UK Modern Slavery Act, 2015 and sets forth its commitment to combat slavery and human trafficking in its business.

OUR BUSINESS AND SUPPLY CHAIN

Quantiphi is an applied AI and data science software and services company driven by the desire to solve transformational problems at the heart of business. It combines deep industry experience, disciplined cloud and data engineering practices, and cutting-edge artificial intelligence research to achieve quantifiable business impact; making products smarter, customer experiences frictionless, and processes autonomous while uncovering anomalies, threats and risks that make businesses safer.

Headquartered in US, the Quantiphi group of companies have presence across US (Marlborough, Princeton, San Jose), Canada (Toronto), UK (London), India, Singapore, and the Netherlands.


Quantiphi’s supply chain mainly consists of its extended workforce employed in servicing clients and supporting our business. Constituting the remaining part of our supply chain are suppliers providing essential services and products (IT equipment, software, etc.) to support Quantiphi’s operations. Quantiphi expects the same standards that it adheres to in relation to combating slavery from all of its contractors, suppliers and other business partners.

OUR POLICIES

- (i) Quantiphi has policies and procedures in place to ensure safeguarding of human rights, and prohibiting slavery and forced labour. Our policies lay down the foundation of our commitment to ensure a safe workplace and provide due guidance on applicable laws, ethical concerns and expected model conduct;
- (ii) Quantiphi encourages employees and other associated individuals to raise any concerns including concerns relating to modern slavery or human rights violations without fear of retaliation or discrimination at workplace;
- (iii) Quantiphi ensures stringent contractual terms with its suppliers to ensure compliance with applicable laws. We place obligations upon our relevant vendors to comply with all applicable laws including the Modern Slavery Act, 2015, and further mandate that the vendors certify their compliance on an annual basis. We have introduced a comprehensive supplier code of conduct for our vendors reiterating the standards of ethics, conduct and integrity we expect from our suppliers; and
- (iv) Quantiphi endeavours to safeguard all its employees and other associated individuals against slavery, servitude, forced or compulsory labour, child labour, and human trafficking of any nature and does not tolerate any form of modern slavery either in its business or supply chain.

Quantiphi is committed to ensuring compliance with human rights and endeavours to eradicate modern slavery in its business. This statement was approved by the board of Directors of Quantiphi Limited on 10th October, 2021
