PURPOSE OF THE STATEMENT

This statement ("Statement") is published by Quantiphi Limited ("Quantiphi") in accordance with the requirements of Section 54 of the UK Modern Slavery Act, 2015 and sets forth its commitment to combat slavery and human trafficking in its business.

OUR BUSINESS AND SUPPLY CHAIN

Quantiphi is an AI-first digital engineering company driven by the desire to reimagine and realize transformational opportunities at the heart of business. Since its inception in 2013, Quantiphi implements deep industry experience, disciplined cloud, and data-engineering practices, and cutting-edge artificial intelligence research to achieve accelerated and quantifiable business results.

Headquartered in the US, the Quantiphi group of companies have presence across US (*Marlborough, Princeton, San Jose*), Canada (*Toronto, Fredericton*), UK (*London*), India, Singapore, the Netherlands and Qatar.

OUR POLICIES

Our policies lay down the foundation of our commitment to ensure a safe workplace and provide due guidance on applicable laws, ethical concerns and expected model conduct.
- ii. Quantiphi encourages employees and other associated individuals to raise any concerns including concerns relating to modern slavery or human rights violations without fear of retaliation or discrimination at the workplace.
- iii. Quantiphi ensures stringent contractual terms with its suppliers to ensure compliance with applicable laws. We place obligations upon our relevant vendors to comply with all applicable laws including the Modern Slavery Act, 2015. We have introduced a comprehensive supplier code of conduct for our vendors reiterating the standards of ethics, conduct and integrity we expect from our suppliers.
- iv. Quantiphi endeavours to safeguard all its employees and other associated individuals against slavery, servitude, forced or compulsory labour, child labour, and human trafficking of any nature and does not tolerate any form of modern slavery either in its business or supply chain.
- v. Quantiphi continuously reviews and updates its policies in line with relevant changes in laws, or global standards.
- vi. Quantiphi's Statement is available at all times to employees through our website.

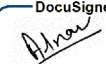
